- 10. Experience certificate along with completion certificate must be enclosed.
- 11. Successful bidder is required to retain existing manpower of NECTAR.

- 12. Successful bidder is required to depute a dedicated supervisor for all communications.
- 13. TA/DA on tour will be provided as per the norms of NECTAR.
- 14. Staffs shall observe the office decorum and protocol, as per the Rules & Regulations of NECTAR or as p er provisions in GOI norms.
